Both resolutions were passed.

Resolution 1:

To grant authority to the Directors to issue shares up to an aggregate nominal amount of of £1,533,546.

Resolution 2:

To authorise the Directors to allot equity securities wholly for cash on a non-pre-emptive basis pursuant to the authority conferred by Resolution 1.
